

Call to nominate practitioners to the Provincial Councils of the Legal Practice Council:
Nomination period extended to 15 February 2019



ADVISORY FROM THE LAW SOCIETY OF SOUTH AFRICA

Dear Colleagues

Following on our advisory of 31 January 2019, we remind you that the Legal Practice Council (LPC) has announced that the period for nomination of practitioners to serve on the Provincial Councils (PCs) of the LPC **has been extended to 15 February 2019**.

Nominations can be made online via the link e-mailed to practitioners or using the PDF form and e-mailing that to lpcprovincialelections@isiqhingi.co.za (You may use either option, but do not use both options.).

Each attorney must nominate only an attorney and each advocate must nominate only an advocate. Nominations are made through the portal link e-mailed to legal practitioners. There are 2 options in which nominations may be submitted for the Provincial Council elections by 15 February 2019:

(PLEASE NOTE: YOU MAY USE EITHER OPTION 1 OR OPTION 2 - do not use both options.)

1. OPTION 1: Online process

To make a nomination click on the link sent to you by the LPC by e-mail and follow the onscreen prompts. You will be required to insert your SA ID Number after you click on the link and then the OTP that is part of the logon process will be sent to your cellphone. Please note that the link provided is not transferable.

2. OPTION 2: Complete and e-mail PDF form
