The Legal Practice Council (LPC) gazetted the draft amended Code of Conduct for public comment on 21 December 2018 in terms of s 36(5) of the Legal Practice Act 28 of 2014 (LPA). The deadline for comment is 7 February 2019.

Practitioners are urged to interrogate the Code carefully and submit their comments either to

### The draft code deals with

- the conduct of attorneys: approaches and publicity; specialisation and expertise; sharing of fees; sharing of offices; payment of commission; naming of partners and practice; replying to communications; naming in deed of alienation; specific provisions relating to conduct of attorneys; misconduct;
- the conduct of referral advocates and advocates with trust accounts;
- the conduct of legal practitioners and candidate legal practitioners in relation to appearances in court and before tribunals: general; interviewing of witnesses of the opposing party in civil proceedings; interviewing of prosecution witnesses by defence legal practitioner; and
- the conduct of legal practitioners not in private practice.

#### ACCREDITATION AND ENROLMENT OF COURT-ANNEXED MEDIATORS

The Department of Justice and Constitutional Development (DoJ&CD) has, through its website, invited applications from suitably qualified persons to be enlisted in its Panel of Mediators to provide mediation services at specified courts/places appointed for the adjudication of civil disputes.

Court-annexed mediation services will, according to the DoJ&CD, be extended to specific Regional Courts in the Eastern Cape, Free State, KwaZulu-Natal, Northern Cape and Western Cape during 2019.

Applicants must complete the prescribed application form and submit it to the relevant

addresses provided on the DoJ&CD's website on or before the closing date of 31 January **2019.** The application form provides, among others, that every applicant for accreditation as a mediator must complete 40 hours of contact training received through an institution which offers mediation training and is approved by the Minister of Justice and Correctional Services.

## ATTORNEYS INSURANCE INDEMNITY FUND: NEW PRESCRIPTION ALERT SYSTEM

In an attempt to enhance its service offering to the profession, the Attorneys Insurance Indemnity Fund NPC (AIIF), has developed a new IT platform on which the Prescription Alert system is run. The Prescription Alert system is a back-up diary system made available to the profession at no cost. All time-barred matters can be registered on the Prescription Alert system.

Prescribed claims remain one of the main sources of professional indemnity claims. Practitioners conducting litigious matters of any sort are encouraged to register their matters on the system and to adhere to the reminders sent out by the system. In terms of the AIIF Master Policy, a penalty deductible (excess) is applied in the event of a claim where the matter was not registered with the Prescription Alert system and/or the reminders sent out by the system.

PRACTICE MANAGEMENT TRAINING FOR LEGAL PRACTITIONERS

In terms of the Legal Practice Act 28 of 2014, practice management training (PMT) must be completed to the satisfaction of the Legal Practice Council before 31 December of the year following the year in which the first Fidelity Fund certificate was issued to a practitioner. This deadline is the latest by when the training must be done. It can be done earlier should the practitioner prefer. In certain circumstances, a practitioner can apply to the Council for an extension or exemption on the basis of prior experience and or qualifications.

The LSSA's legal education and development section, LEAD, has been accredited by the Legal Practice Council to provide PMT in 2019. The registration deadline for the second intake for 2019 is 31 May 2019. The course will start in July 2019. Read more here.
