DIRECTIVE FOR ELECTRONIC FILING OF PROCESSES, NOTICES AND OTHER DOCUMENTS AT REGIONAL COURT CIVIL SEATS

With reference to the measures adopted by the Heads of Court to curb the spread of COVID-19 and the subsequent Directives issued by the Chief Justice on 17 March 2020:

- (1) As the Rules regulating the Conduct of the proceedings of the Magistrates' Courts of South Africa provide for electronic filing of processes, notices and related documents, centralized email addresses have been created for the 14 Regional Court Civil Seats in the Limpopo Regional Division.
- (2) Legal Practitioners are urged to use the central email address of the Regional Court Civil Seat they need to file any court process, notice or related document at, instead of having it filed in person.
- (3) The central email address of the relevant Regional Court Civil Seat must also be included on all court processes to be issued together with the physical address as an address for filing of for example the notice to defend.
- (4) When Practitioners use the central email addresses, the delivery and read receipts options must be used and such receipts printed to be produced at court if necessary.
