#### LSSA SHOCKED AND SADDENED AT THE DEATH OF FORMER COUNCIL MEMBER, LUTENDO SIGOGO

The Law Society of South Africa (LSSA) is shocked and saddened to learn about the untimely death of an esteemed member of the legal profession, Limpopo attorney and former LSSA Council member, Lutendo Sigogo. He died from COVID.

At the time of his death, Mr Sigogo was a Director of Mathobo Rambau and Sigogo Incorporated. Mr Sigogo served as President of the Black Lawyers Association (BLA) for two terms. He is also a former President of the then Law Society of the Northern Provinces. In a press release, LSSA President Jan van Rensburg said: 'The death of Mr Sigogo is a huge loss to the legal fraternity. We honour his legacy and mourn his loss alongside his family, friends, and the legal profession.'


