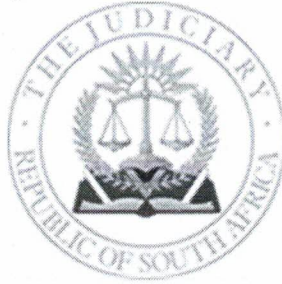



RE: DIRECTIVE: APPLICATION FOR DEFAULT JUDGMENTS IN MATTERS SUBJECT TO THE PROVISIONS OF THE NATIONAL CREDIT ACT, 34 of 2005

1. Default judgments falling within this category will be heard by Judges via the virtual platform.
2. The Registrar will publish a roll with the matters allocated for a specific week and, save if so directed by the presiding Judge, no appearance on behalf of the applicant will be necessary.

3. If the application for default judgment was not filed within 6 months from the date of service of the summons, the attorney on behalf of the applicant must file an affidavit explaining the reasons why the application was not filed within six months.
